Health Commissioner Stan Saalman recognized the many individuals and agencies that protect public health in Richland County at the Public Health Day breakfast, April 5.

The group of dentists from the Mansfield Dental Society volunteer their time to give free dental exams and corrective procedures for children whose parents have no insurance to pay for these services and who also meet income qualifications. Skip Allman of United Way, which helps fund the Clinic, accepted the award on behalf of all the dentists who volunteer their time.

## Flu Vaccine Response

After a chaotic 2004 flu season brought on by a vaccine shortage, no one knew what to expect in 2005. However, the Health Department had an ample supply of shots. The first clinic was moved to the Richland County Fairgrounds to handle the expected crowds and a record 1,214 vaccinations were done the first day. Eventually, 9,104 shots were given in 2005 by both Public Health Nursing at satellite locations and by nurses at the Public Health Clinic. Shots continued into 2006 until the supply was exhausted.



# WIC: Women, Infants & Children

Women, Infants, Children (WIC) is a health and nutrition program for pregnant and breast-feeding women, families with infants, and children under age five.

WIC provides nutrition education, referral to health care, a breast pump program and coupons redeemable for nutritious foods at approved grocery stores and Farmer's Markets.

The total number of WIC coupons issued for 2005 was 132,212. The value of these coupons was \$2,192,802.60, a significant boost to our Richland County economy. WIC participants served during 2005 averaged 3,252 per month. Highlights for 2005 were:

- · Special National Nutrition Month activities in March
- · WIC Tea for Breast-feeding Moms in August
- · Third Birthday Party for WIC children
- · Baby Shower for prenatal WIC participants
- · Special activities for Halloween and Christmas



#### From the Commissioner

On October 31, 1918, with our nation in the grip of a pandemic flu that would kill half a million in the U.S., our Board of Health issued the following:

- 1) No public meeting be held inside any building.
- 2) All billiard and pool rooms and bowling alleys



- 4) There shall be no crowding, congregating or loafing in any store or other place of business...
- 5) All special sales of goods or wares are prohibited if they cause any crowding.

Last year, our health department was advised by Centers for Disease Control and the Ohio Department of Health to make preparations and plans to respond to a potential new pandemic flu. Though we had been on alert for a potential pandemic flu outbreak for several years, that threat became imminent with the global spread of Avian (bird) Flu that has been shown to have a fatality rate above 35% when contracted by a person.

Our health department has developed plans and will continue our preparations into 2006. We will also begin educating other agencies, businesses, government officials and citizens about planning and preparations they should begin doing.

While we pray we will never need these plans to face a new pandemic flu like the one in 1918, we know there is always value in emergency planning. There will always be new communicable diseases that will require responses to protect the public health. We will be prepared and respond accordingly.
